



# COSSACK LABS LIMITED PRIVACY POLICY

This Privacy Policy describes how your personal information is collected, used, and shared when you visit or subscribe to <https://www.cossacklabs.com/> (the “Site”) and all its subdomains via the subscription and/or registration form(s) present on the Site. By accessing the Site you agree to the terms of the Privacy Policy. If you do not agree to the terms of this Privacy Policy, please do not access or use Cossack Labs Limited website(s).

## PERSONAL INFORMATION WE COLLECT

When you visit the Site, we automatically collect certain information about your device, including information about your web browser, IP address, time zone, device model. Additionally, as you browse the Site, we collect information about the individual web pages or products that you view, what websites or search terms referred you to the Site, and information about how you interact with the Site. We refer to this automatically-collected information as “Device Information.”

We collect Device Information using the following technologies:

- “Cookies” are data files that are placed on your device or computer and often include an anonymous unique identifier. For more information about cookies, visit the Cossack Labs [Cookie Policy](#) page. To find out how to disable cookies, we recommend visiting a third-party website <http://www.allaboutcookies.org> (Cossack Labs Limited is not responsible for the information and the possible losses caused by using the information provided at <http://www.allaboutcookies.org>).
- “Log files” used by third-party user data collectors ([Piwik](#)) track actions occurring on the Site and collect data including your IP address, browser type, Internet service provider, referring/exit pages, and date/time stamps.

When we talk about “Personal Information” in this Privacy Policy, we are talking both about Device Information and user emails/passwords.

The products of Cossack Labs Limited collect no user data, sensitive or whatsoever.



The only place where the users' Personal Information (emails and passwords) might be collected is the subscription and registration forms on the Site (<https://www.cossacklabs.com/>) and its branches in the same domain (i.e. <https://themis.cossacklabs.com/>, <https://docs.cossacklabs.com/>. etc.). We only store the emails (in encrypted form) and password hashes (meaning the passwords are never stored in plaintext and are safe with us).

## **HOW DO WE USE YOUR PERSONAL INFORMATION?**

We use the Device Information that we collect to improve and optimize our Site (for example, by generating analytics about how our visitors browse and interact with the Site, and to assess the success of our marketing and advertising campaigns).

## **SHARING YOUR PERSONAL INFORMATION**

We do not share your Personal Information with third parties except for [Piwik](#). And we use Piwik only to help us understand how our Site is used by the visitors and to improve the user experience of visiting the Site.

## **YOUR RIGHTS**

You have the right to access the Personal Information we hold about you and to ask that your Personal Information is corrected, updated, or deleted. If you would like to exercise this right, please contact us through the contact information provided below.

## **DATA RETENTION**

When you leave your name or email through the subscription form(s) on the Site, we will maintain your Information for our records unless and until you ask us to delete this information.

## **MINORS**

The Site is not intended (but is not prohibited for visiting) for individuals under the age of 16. It contains no inappropriate information for minors (or persons of any age), but we consider data security and encryption a matter of interest mostly for people with at least a high-school level of knowledge of computer science so we use the language of complexity appropriate for persons of age 16+.

## **DOCUMENTATION SERVER**

An integral part of the Site is to be found at the address <https://docs.cossacklabs.com/>. We refer to this part of the Site as Documentation Server for convenience. All the terms of service and Privacy Policy apply to it similarly to the Site, even though visually it employs a design slightly different to that of the main portion of the Site.

## **CHANGES**

We may update this Privacy Policy from time to time in order to reflect, for example, changes to our practices or for other operational, legal or regulatory reasons. In case of minor wording changes to our Privacy Policy (i.e. adding more detailed descriptions of the practices we use



for storing and processing user data) we reserve the right not to notify the users about such changes at all so as not to spam up our users' email inboxes (because we hate spam as much as everyone else). However, you can request to be notified about all and any changes in our Privacy Policy by sending us an email with a topic "Send me all PP notifications" to [info@cossacklabs.com](mailto:info@cossacklabs.com). Sending such an email is considered as giving Cossack Labs Limited an explicit consent for being sent notifications about all and any changes to our Privacy Policy.

## **GDPR PRIVACY NOTICE**

To comply with the [GDPR](#), Cossack Labs Limited will be what's known as the 'Controller' of the personal data you provide to us. The handling of the data by Cossack Labs Limited is described above.

### **Why we need your data**

We need to know your basic personal data (email and cookie data) in order to provide you with product and website updates and news after receiving an explicit consent from you to receive such information (already described in this Privacy Policy), as well as to provide you the best user experience when you visit our Site.

### **How long we keep your data**
